More Big Plans

Some East Main Street open space may not be open forever. The property, owned by the Roe family, is on the north side, just west of Maple Ave. It was the location of the Kiwanis Club of Patchogue's first Oktoberfest, back in the 80's. It served as a beer garden during a couple of Alive After Five's, and the Knights of Columbus have decorated it for Christmas.

Now, a plan which has just entered the Village permitting process would utilize it in a big way.

D&F Development, LLC is proposing a seven story assisted living residence with 144 beds, and behind it a six story senior living complex.

TRITEC Waits Until March 1



The Patchogue Village Board, unable to agree on TRITEC's plan to amend its approved Four Corners project to substitute 51 apartments for a 111 room hotel has put off until March 1 a decision on the change. The board will hold a special meeting then at 7:30 p.m. In the meantime, written comments will be accepted until Feb. 14. The Planning Board has also been brought in on consideration and will meet with the trustees on Feb. 17. Talks with TRITEC also continue.

Public comment at the Jan. 24 trustee meeting showed village residents divided on the \$100 million project. Some objected to the total 291 apartments in the 4 acre mixed use project while others welcomed them. Concerns were also raised about sufficient parking.

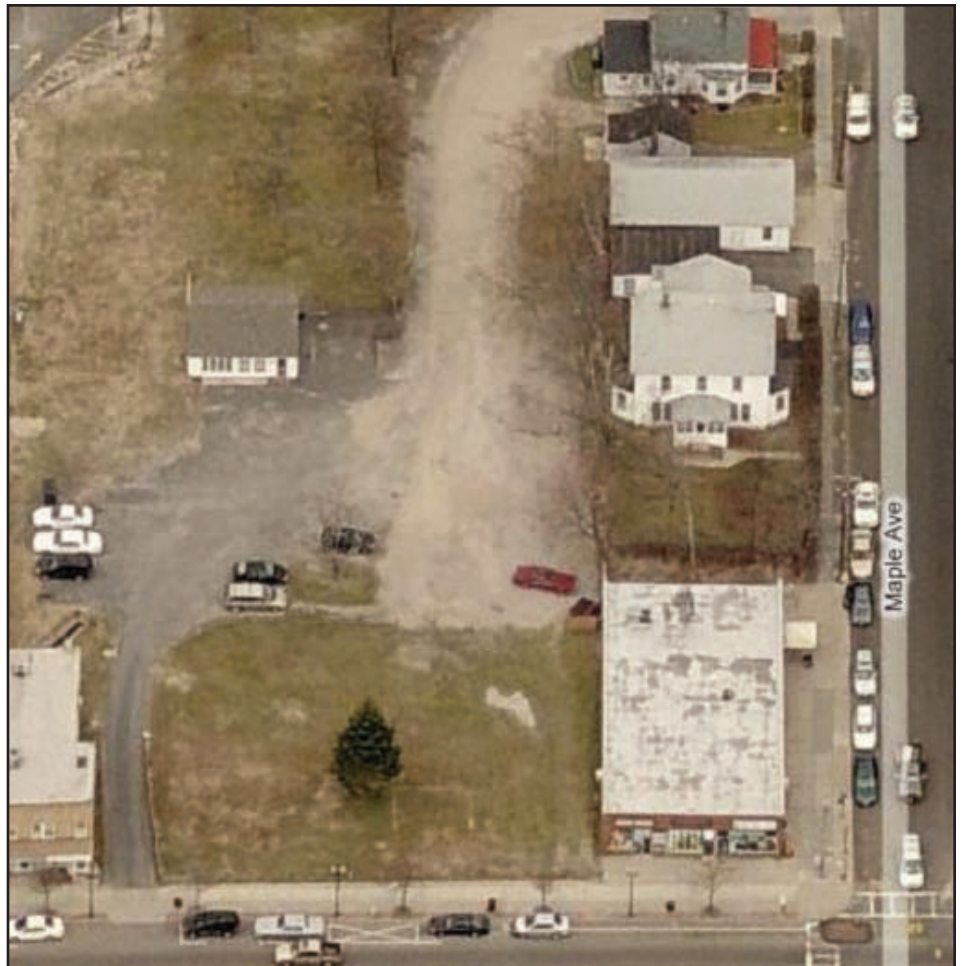

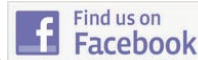
