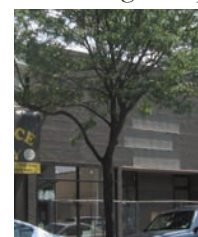


This new Dove Bldg. renovation has spruced up the Four Corners.

Walmart Loses A Round

The Brookhaven Town Board has rescinded a 2005 zoning decision to remove from potential Walmart use 3 acres of the nearly 15 acres of property on which a 120,000 square foot store had been proposed. The rescission changes the 3 acre zoning from commercial to office. It appears to mean that a somewhat smaller store—92,000 square feet would be needed to fit the remaining commercial property at Hospital Road and the Sunrise Highway North Service Road in East Patchogue.

How Walmart plans to proceed is not known yet. There is considerable opposition, including formal opposition by the Greater Patchogue Chamber of Commerce, to any large box store at the site.

The chamber is concerned about the effects on the character of local downtowns and traffic issues on the narrow bridge that approaches Brookhaven Memorial Hospital.
